As one of South Florida's largest employers, Carnival Cruise Lines is a dedicated community leader. Over the past five years, the Carnival Foundation has raised more than \$30 million in monetary funds and in-kind services for local and national charities. Carnival employees are also involved in charitable acts, including volunteering at orphanages throughout the Caribbean and United States.

Under the leadership of Executive Director Linda Coll, the Carnival Foundation is an involved partner with Miami-Dade County Public Schools' (M-DCPS) career academy programs. Since 1987, the foundation has donated \$5,000 annually to the school district. In addition, 10-15 student interns have been hired every year for the past 21 years.

The Carnival Foundation supports M-DCPS students and parents through professional development events, mentoring programs, and providing graduates with career opportunities. The school district champions programs that offer students hands-on experience and prepares them for a meaningful career. The Academies of Hospitality and Tourism and Information Technology are part of the School Choice and Parental Options Office and are members of the National Academy Foundation (NAF). NAF is a national network of career academies that supports the personal and professional success of youth beginning in high school, and continuing through to professional careers. The school district currently has 11 Academies of Hospitality and Tourism and 12 Academies of Information Technology.
