## **RESOLUTION NO. 16-104** OF THE SCHOOL BOARD OF MIAMI-DADE COUNTY, FLORIDA, RECOGNIZING M. GARY NEUMAN SCHOOLS

WHEREAS, M. Gary Neuman developed The Sandcastles Program™, a group experience for children of divorce mandated in many divorce courts. Over 300,000 children have completed the Program internationally; and

WHEREAS, The Sandcastles Program™ is a three-and-a-half-hour, onetime group session for children of divorce between the ages of six and 17. The last half hour includes the children's parents and focuses on improving communication between them; and

WHEREAS, the Program was first instituted in Miami-Dade County, Florida, and is now mandatory there and in over a dozen other jurisdictions throughout the country. In these counties, no final divorce decree will be granted to any couple whose minor children do not participate in The Sandcastles Program™; and

WHEREAS, as a result of meeting with peers who are going through a similar experience, children usually emerge with a newfound sense of confidence, hope, and community. They realize that they are not alone, that it is normal to feel anxious, angry, sad, and confused; and

WHEREAS, the Program uses a range of innovated techniques designed to help children: develop self-expression and problem-solving skills, learn appropriate means of expressing anger and other intense emotions, reach a better understanding of the reality of divorce, recognize their own unique qualities and strengths; and

WHEREAS, each child receives an age-appropriate workbook, which he or she fills out anonymously and children are invited to draw pictures, write poems, compose letters to their parents, answer questions about their divorce experience, and more. In addition to writing and drawing, the participants are guided in such activities as role-playing, discussion, and interviewing fellow group members. In the last half-hour, parents meet with their children and learn techniques for interacting and expressing their feelings about divorce. At the end of each session, participants complete a written evaluation of their Sandcastles experience, as do their parents, in a follow-up questionnaire completed afterward.
