Mr. Rateau has become involved in the 5000 Role Models of Excellence chapter at Ojus Elementary. He has attended meetings and volunteered to serve as a mentor to older students who are considered "at risk" and who may not have a positive male role model in their lives. Mr. Rateau was Ojus' Principal for the Day during the 2019-2020 school year and is an integral member of the Ojus family. Mr. Rateau has promoted the involvement of fathers and father figures in children's education and empowers young children to reach their potential.

This year, Mr. Rateau became a member of the PTA. Some of his service has included reading to students, serving as a chaperone on field trips, providing motivational talks for students, and helping to set up and gain sponsors for Teacher Appreciation events. He has worked with students at almost every grade level. He credits his parents for the approach he takes as a volunteer and for helping him look at other things for the better.
