The "I Have a Dream" program was launched in 1981 when founder Eugene Lang returned to his alma mater in East Harlem to address the graduating sixth-grade class. When he learned that three-quarters of the school's students would probably drop out of school, Lang promised college tuition to every sixth grader who graduated from high school. The results were truly amazing. Ninety percent of those sixth graders graduated from high school, and sixty percent went to college.

This remarkable accomplishment led to the creation of the "I Have a Dream" Foundation, which consists of 35 affiliates across the United States, and one in New Zealand. Within those 35 affiliates, there are 65 current cohorts serving more than 4,000 Dreamers in 30 U.S. cities.

The Miami chapter was founded in 1995 by the Trump Family. Since sponsoring Miami's first "I Have A Dream" program in 1995, Stephanie Trump has helped grow Miami into one of the largest "I Have A Dream" regions in the country, with nearly 800 Miami Dreamers ranging from second graders to college students. In the Miami Chapter's first graduating class in 2005- 83 out of 97 children graduated from Liberty City and 72 went to college. Ms. Trump was so inspired by the success of her first Dreamer class that, soon after their graduation from high school, she sponsored another class - this time serving 96 kindergarteners in North Miami Beach - and also co-sponsors another cohort of Miami students.
