Despite the amount of artists it took to make this event a success, the day was also made possible by over 50 volunteers that gave their time and assistance. } Revised

Apart from its educational and entertainment value, Cultural Arts Day affords our students the opportunity to find their own inspiration, their own muse, perhaps, from one or more of the varied offerings. The students are introduced to artistic activities they can pursue in middle school, high school and beyond. During Cultural Arts Day, the entire school population of 750 students, grades Pre-K- fifth grades are encouraged to participate and interact with the 28 performing artist groups. Each class is assigned to six artists of which they rotate through in twenty minute increments. The annual event, for five decades has exposed students to the many forms of the arts from painting and violin music to ballet and Tae Kwon Do. } Revised
